**ORDINANCE NO. 170, S. 2012**

AN ORDINANCE AMENDING ORDINANCE NO. 124, SERIES OF 2008 OTHERWISE KNOWN AS THE "MUNICIPAL TRAFFIC CODE OF BONTOC, MOUNTAIN PROVINCE"

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF THE MUNICIPALITY OF BONTOC THAT:


SECTION 1 – Ordinance No. 124, Series of 2008 otherwise known as the Municipal Traffic Code of Bontoc, Mountain Province specifically Section 15.g2 is hereby amended, reducing the grace period of delinquent Tricycle Operator from six (6) months to three (3) months after three consecutive notices.


Operator in possession of Tricycle Franchise who fails to register his/her franchise three months after its expiry date shall be suspended to operate and the franchise revoked.

SECTION 2 – Separability Clause: Except for Section 15.g2 of which is hereby amended, all other sections of Ordinance No. 124, Series of 2008 shall remain in effect and that this Ordinance shall form part of Ordinance No. 124, Series of 2008

SECTION 3 – Effectivity – This ordinance shall take effect immediately upon approval by the Local Chief Executive unless declared otherwise in the review of the Sangguniang Panlalawigan;


