AN ORDINANCE REALIGNING APPROPRIATIONS IN THE BONTOC MUNICIPAL AIP, CY 2012
and CY-2013

BE IT ENACTED by the SANGGUNIANG BAYAN, in session assembled, that:

SECTION I. FUND REALIGNMENTS FROM THE AIP 2012 – Unimplemented
appropriations in the CY-2012 Municipal AIP are hereby realigned as follows:

- a) The amount of ONE HUNDRED THOUSAND PESOS (P100,000.00) FROM
Planning & Investment Programming, Assistant & Evaluation is hereby realigned TO
augment the Municipal Labor Counterpart For The Completion of Dalican Barangay
Health Station;
- b) The amount of TWENTY THOUSAND PESOS (P 20,000.00)FROM
CONSTRUCTION OF MRF, under Code 9000.6.2 – is hereby realigned TO ECO -
COMPOSTING RECEPTACLE;

SECTION 2 – FUND REALIGNMENTS FROM THE AIP 2013 – reprioritized
appropriations in the CY 2013 Municipal AIP are hereby realigned as follows:


- a) THE FIFTY THOUSAND PESOS (P50,000.00) for Construction of Tocucan
Pathway, under code 9000.6.2 is hereby realigned
TO: PAREW FOOTPATH – P25, 000.00
PAKKIL DRAINAGE – P25, 000.00

SECTION 4 – REPEALING CLAUSE – The pertinent portions of the Municipal AIP cy
2012 and CY 2013 and other municipal document affected by this ordinance are hereby repealed
or modified accordingly;
