**ORDINANCE NO. 213, S. 2013**

**AN ORDINANCE AMENDING THE TRICYCLE FARE AMOUNTS MANDATED UNDER SECTION 1(a) and SECTION 2 OF MUNICIPAL ORDINANCE NO. 128,S.2008, AND FOR OTHER PURPOSES.**

**EXPLANATORY NOTES**

1. On June 3,,2013, the Sangguniang Bayan enacted Ordinance NO. 207,S.2013 titled "AN ORDINANCE AMENDING SECTION 1 (a) and SECTION 2 OF ORDINANCE NO. 128,S.2008 APPROVING THE REGULAR TRICYCLE FARE PEGGED AT P9.00 FROM THE ORIGINAL MINIMUM FARE OF P7.00."
2. The afore-cited ordinance was submitted to the Sangguniang Panlalawigan for review pursuant to Section 54,LGC 1991, which in turn referred the same to the Provincial Attorney for study and recommendation;
3. Subsequently, the Provincial Attorney in his June 14,2013 5<sup>th</sup> Indorsement, recommended to the Sangguniang Panlalawigan that said ordinance No. 207, S..2013 be held in abeyance on the reasons that it did not comply the 3 readings rule of legislation and that if it is not in the proper form of an amendatory ordinance;
4. Consequently, the Sangguniang Panlalawigan, in its Resolution No. 2013-154, June 24,2013, returned Ordinance No. 207,S.2013 to the Sangguniang Bayan of Bontoc for consideration of the Provincial Attorney's comments and the compliance thereof.
5. That a public hearing was conducted on September 6,2013, at the Municipal quadrangle where the amounts of P9.00 regular fare and P7.00 discounted fare were approved in a consensus by the participants.

WHEREFORE, Foregoing premises considered, and on motion seconded.

BE IT ENACTED BY THIS SANGGUNIANG BAYAN, in session assembled that:

SECTION 1 - The "MINIMUM FARE" provision of Section 1 (a) of Ordinance No. 128,S.2008 is hereby amended to read as follows:

"MINIMUM FARE - A NINE PESOS (P9.00) fare shall be charged for any tricycle travel covering any distance within the cut-off points which is less than the full and complete distance between any two (2) cut-off points specified herein."


SECTION 2 – Students, Senior citizens, Person With Disability shall be entitled to a fixed discounted fare of SEVEN PESOS (P700), provided that students are not entitled to such discount fare, and shall pay P9.00 minimum fare during Saturdays, Sundays and holidays:


SECTION 3 – SEPARABILITY CLAUSE – The parts/provisions of this Ordinance are separable. Any part/provision hereof which maybe declared invalid shall not invalidate the other parts/provisions not so specifically declared invalid.



SECTION 5 – EFFECTIVITY CLAUSE - This ordinance shall take effect after 15 days from publication.


