SECTION 1 – SOURCE OF FUND:


A. Repair and Maintenance office Equipment/ furniture/ IT Equipment -	P 120,000.00

SECTION 2 – APPROPRIATION – Repair of Engineering Office P 185,000.00


SECTION 3 – REPEALING CLAUSE – This Ordinance repeals the MOOE of the CY 2013 Annual Budget of the Engineering Office.






