**ORDINANCE NO. 223, S. 2013**

**AN ORDINANCE REALIGNING 2013 MUNICIPAL FUND ALLOCATIONS OF THE BUREAU OF FIRE PROTECTION, FROM TRAINING OF FIRE BRIGADE – P 30,000.00 (ACCOUNT CODE 753) AND REPAIR AND MAINTENANCE OF THE FIRE TRUCK – P 25,180.00 (ACCOUNT CODE 841) FOR A TOTAL AMOUNT OF P 55,180.00 - TO RENOVATION OF COMFORT ROOM AND CONCRETING OF THE PARTITION OF THE FIRE TRUCK GARAGE AND KITCHEN.**

WHEREAS, approved during the December 9, 2013 regular session of this Sangguniang Bayan is a request from the Municipal fire marshal endorsed by the Municipal Mayor for the realignment of their CY 2013 municipal budget for training of fire brigade in the amount of P 30,000.00 and repair and maintenance of fire truck in the amount of P 25,180.00 totaling P 55,180.00 - to renovation of comfort room, and concreting of the partition of the fire truck garage and kitchen;

BE IT ENACTED BY THE SANGGUNIANG BAYAN IN SESSION ASSEMBLED THAT:

Section 1. the sum of FIFTY FIVE THOUSAND ONE HUNDRED EIGHTY PESOS from the municipal allocation of the Bontoc Fire Station \_BFP is hereby realigned as follows:

A. FUND SOURCE: a) training of fire brigade – (code 753) P 30,000.00  
b) repair and maintenance of Fire truck – (code 841) 25,180.00  
P 55,180.00

B. APPROPRIATION: a) renovation of comfort room and concreting of the partition of the fire truck garage and kitchen.

Section 2. REPEALING CLAUSE – This ordinance repeals the affected portion of the 2013 Municipal Annual budget.

Section 3. EFFECTIVITY: This ordinance takes effect upon approval by the Chief Executive.
