
BE IT ENACTED BY THE SANGGUNIANG BAYAN IN SESSION THAT:


- a) Purchase of Uniform Fuyayeng Organization - - - - - P7,000.00

- TOTAL: P262,000.00






SECTION 2. EFFECTIVITY – This ordinance takes effect upon approval by the Local Chief executive






