ORDINANCE NO. 229, S. 2014

An ordinance realigning P255,000.00 from the P1,500,000.00 Reallocation/Reorganization Fund under the NON-OFFICE appropriations in the 2014 Municipal Annual Budget – To Representation and Transportation Allowance of the ABC President and IP Representative in the Sangguniang Bayan.

EXPLANATORY NOTES

1. No RATA for the Ex-officio Sanggunian Members were appropriated in the 2014 municipal annual budget of Bontoc;
2. RATA is an item of the personal Services expense pursuant to 4.1.1.1. of DBM Local Budget Circular No. 98 dated October 14, 2011, and the Reallocation/Reorganization Fund in the Non-Office expense of the 2014 municipal annual budget is an M.O.D.E item – Thus that the transfer of appropriation from one to the other is as pursuant to Section 336 of RA 7160.

BE IT ORDAINED, by the Sangguniang Bayan, in session assembled, that;






SECTION 3. EFFECTIVITY – This ordinance takes effect after review approval.


