ORDINANCE NO. 231, S. 2014

AN ORDINANCE ABOLISHING THE EXISTING VACANT PLANTILLA POSITION AGRICULTURAL TECHNOLOGIST, SG-10 AND CREATING THE POSITIONS OF FARM FOREMAN, SG-6 AND FARM WORKER, SG-4 OF THE MUNICIPAL AGRICULTURAL OFFICE.

EXPLANATORY NOTE

PURSUANT TO SECTION 76 OF R.A. 7160, Local Government Code of 1991, Provides: ORGANIZATIONAL STRUCTURE AND STAFFING PATTERN, "EVERY LOCAL GOVERNMENT UNIT SHALL DESIGN AND IMPLEMENT ITS OWN ORGANIZATIONAL STRUCTURE AND STAFFING PATTERNS TAKING INTO CONSIDERATION ITS SERVICE REQUIREMENTS AND FINANCIAL CAPABILITY, SUBJECT TO THE MINIMUM STANDARDS AND GUIDELINES PRESCRIBED BY THE CIVIL SERVICE COMMISSION."

SECTION 2 of 2.5 on the CSC MC No. 19, S. 1992, states that "IN CASES OF ABOLITION OF POSITIONS AND THE CREATION OF NEW ONES RESULTING FROM THE ABOLITION OF EXISTING POSITIONS IN THE CARREER SERVICE, SUCH ABOLITION OR CREATION SHALL BE MADE IN ACCORDANCE WITH PERTINENT PROVISIONS OF THE CODE AND THE CIVIL SERVICE LAW, RULES, AND REGULATIONS,

WHEREFORE, foregoing considered.

BE IT ENACTED, By this Sangguniang Bayan in session assembled, that:

SECTION 1 - ABOLITION OF THE EXISTING VACANT POSITION OF AGRICULTURAL TECHNOLOGIST, SG-10 AND CREATING NEW POSITIONS IN PLACE THEREOF.

TO BE ABOLISHED

1. AGRICULTURAL TECHNOLOGIST, SG-10

TO BE CREATED

1. FARM FOREMAN, SG-6  
2. FARM WORKER, SG-4




SECTION 4 - EFFECTIVITY - This ordinance shall take effect fifteen days upon posting in the Municipal Hall Bulletin board.




