ORDINANCE NO. 234, S. 2014

AN ORDINANCE REALIGNING/REAPPROPRIATING FUNDS IN THE AMOUNT OF P127,250.08 FROM THE BALANCE OF ITEM NO. 9000-10-1 COUNTERPART FOR INREMP/PRDP OF THE CY 2014 MUNICIPAL AIP FOR VARIOUS PROGRAMS OF THIS MUNICIPALITY.

BE IT ORDAINED by the SANGGUNIANG BAYAN, in session assembled, that:

SECTION I. FUND REALIGNMENT/REAPPROPRIATIONS – The amount of P127,250.08 from the balance of item No. 9000-10-1 - counterpart for INREMP/PRDP of the CY 2014 municipal AIP are hereby realigned/reappropriated, to wit:


1. Counterpart for the provision of feeds supply for swine breeding - - - - P12,750.08
 2. Counterpart for dispersal project, swine fattening/gout
For the 16 Barangays - - - - -P25,000.00
 3. Counterpart-organic composting plant - - - - - P61,500.00
 4. Additional fund for biometrics - - - - - P28,000.00
- T O T A L - - - - -P127,250.08


SECTION 2 – REPEALING CLAUSE – The pertinent portions of the CY 2014 municipal AIP and other documents are hereby amended accordingly;


SECTION 3 – SEPARABILITY CLAUSE – Parts of this ordinance which maybe declared invalid shall not affect the other parts not so invalidated;


SECTION 4 – EFFECTIVITY – This ordinance takes effect after 15 days publication/posting in the bulletin board.






