ORDINANCE NO. 235, S. 2014

AN ORDINANCE REALIGNING MOOE FUNDS TO CAPITAL OUTLAY, OF THE SANGGUNIANG BAYAN OFFICE

Be it ordained by the Sangguniang Bayan in session assembled, that:

SECTION 1 - FUND REALIGNMENTS - The following MOOE funds/appropriations in the 2014 annual budget of the Sangguniang Bayan Office, are hereby realigned respectfully as follows:

1. FIFTEEN THOUSAND PESOS (P15,000.00) FROM Office Supplies (Municipal Library), TO purchase of one unit steel GONDOLA/GORILLA RACK with plywood flooring, for the Municipal Library;
2. The TWENTY ONE THOUSAND SIX HUNDRED PESOS (P21,600.00) FROM the balance of NAMEPLATES which was transferred to augment LIBRARY PROGRAMS under Resolution No. 617,S.2014, TO purchase of one unit AIR COOLER.
3. The THIRTY THOUSAND PESOS (P30,000.00) FROM CCTV Operation/Services, TO augment the fund for a SCANNER.




SECTION 4 - EFFECTIVITY - This ordinance takes effect upon executive approval.
