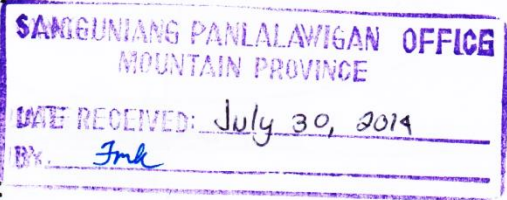

ORDINANCE NO. 237, S.2014

AN ORDINANCE AMENDING SECTION III (1) ON SENIOR CITIZENS SPECIAL DAY and SECTION V (b)- FUNDING OF ORDINANCE NO. 144-A, S. 2009 OTHERWISE KNOWN AS "AN ORDINANCE DECLARING EVERY 1st MONDAY OF OCTOBER OF EACH YEAR AS A SENIOR CITIZENS DAY AND ACT AS SENIOR CITIZENS OFFICER FOR A DAY (SCOFAD) FOR THE ELECTIVE POSITIONS IN THE MUNICIPALITY OF BONTOC AND PROVIDING INCENTIVES THEREOF."

WHEREFORE, Be it ordained by the Sangguniang Bayan in session assembled that:

SECTION 1. Section III (1) "Came from the Federation Officers of the Bontoc Municipality," of Ord. No. 144-A, S. 2009 is hereby amended to read as follows:

"Come from the Different Barangay Senior Citizens Officer of the Bontoc Municipality".

SECTION 2. Section V (b) of Ordinance No. 144-A, S. 2009 is hereby amended to read:

b) The SCOFAD shall receive an incentive as follows:

I) SCOFAD Mayor - -----	P1,100.00	P1,200.00
II) SCOFAD Vice Mayor - -----	P1,000.00	P1,100.00
III) SCOFAD Councilors and Ex-Officios - -----	P9,900.00	<u>P1,000.00/each</u>
	P12,000.00	P12,300.00

SECTION 3. SEPARABILITY CLAUSE – Any Provisions of this ordinance declared invalid by authority shall not invalidate other provisions not declared invalid.

SECTION 4. REPEALING CLAUSE – All parts or portions of Ordinance No. 144-A, S. 2009 which are inconsistent herewith are hereby repealed or modified accordingly

SECTION 5. EFFECTIVITY - This ordinance shall take effect upon approval by the Sangguniang Panlalawigan.
