ORDINANCE NO. 238, S. 2014

AN ORDINANCE REALIGNING APPROPRIATIONS/FUNDS IN THE NON-OFFICE PORTION OF THE 2014 MUNICIPAL ANNUAL BUDGET - TO CAPITAL OUTLAY REQUIREMENTS, SPECIFIED HEREIN BELOW

EXPLANATORY NOTE

The Sangguniang Bayan was requested by the Municipal Mayor in a letter dated July 8, 2014 for an urgent measure to realign funds.

BE IT ORDAINED BY THIS SANGGUNIANG BAYAN, in session assembled, that:

SECTION 1 - FUND REALIGNMENTS - The following REALIGNMENTS of Municipal Appropriations are hereby authorized, to wit:

1. ONE HUNDRED TWENTY THOUSAND PESOS (P120,000.00) is hereby realigned FROM: PHILHEALTH municipal sponsored fund, under item 8-GAD Fund, NON-OFFICE, 2014 Municipal Annual Budget - TO: Soil Testing of proposed multi-purpose building site which is a legal requirement for the construction of public buildings;
2. ONE HUNDRED THOUSAND PESOS (P100,000.00) is hereby realigned FROM : MUNICIPAL SCHOLARSHIP FUND, under item 8-GAD Fund, NON-OFFICE, 2014 Municipal Annual Budget - TO: Purchase for a Water Reservoir Landsite at Lanao, Bontoc Ili.






SECTION 4 - EFFECTIVITY - This ordinance takes effect upon executive approval.

Ordained on July 14,2014.


