The Mayor's request of P500,000.00 realignment from the REALLOCATION/REORGANIZATION FUND under item 6 of the NON-OFFICE in the 2014 Municipal Annual Budget had been presented for First Reading on July 7, 2014 and approved on Second Reading on July 14, 2014, and finally approved on Third Reading on July 28, 2014;
2. The Mayor's request for the P6,000.00 realignment from the OFFICE SUPPLIES FUND of the BUREAU OF FIRE PROTECTION - MUNICIPAL OFFICE to Purchase of One Unit Cannon MP 287 Printer with Continuous Ink Flow System was calendared and approved under Unassigned/Urgent Matters - it being requested by the Mayor to be treated as urgent.

WHEREFORE, On motions duly seconded,

BE IT ORDAINED, By this Sangguniang Bayan, in session assembled, that:

SECTION 1 - FUND REALIGNMENTS - NON OFFICE AUGMENTATION TO:

- a) MAYOR'S OFFICE - The amount of FIVE HUNDRED THOUSAND PESOS (P500,000.00) is hereby realigned from the REALLOCATION/REORGANIZATION FUND under item 6 of the NON-OICE APPROPRIATIONS of the 2014 Municipal Annual Budget - TO AUGMENT EXECUTIVE PROGRAMS, Environmental and Social Programs and Health and Sanitation Programs of the MAYOR'S OFFICE,
- b) BUREAU OF FIRE PROTECTION MOOE TO CAIPTAL OUTLAY - The amount of SIX THOUSAND PESOS (P6,000.00) is hereby realigned from the current OFFICE SUPPLIES FUND of the Bureau of Fire Protection - Municipal Office (2014 Municipal annual Budget) - TO PURCHASE OF A CANNON MP 287 COMPUTER PRINTER with continuous Ink Flow system for the same office.
