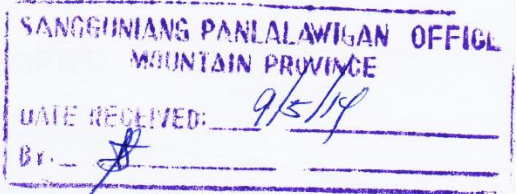

ORDINANCE NO. 240, S. 2014

AN ORDINANCE TO TRANSFER THE POSITION OF ADMINISTRATIVE AIDE III (DRIVER I) FROM THE OFFICE OF THE VICE MAYOR TO THE OFFICE OF THE MUNICIPAL MAYOR, AND THE POSITION OF ADMINISTRATIVE AIDE I (UTILITY WORKER I) FROM THE ACCOUNTING OFFICE TO THE OFFICE OF THE MUNICIPAL PLANNING AND DEVELOPMENT OFFICE (MPDO).

WHEREAS, in the exigency of the service the Municipal Mayor requested the transfer of one position item from the Office of the Vice Mayor to the Office of the Municipal Mayor, and one position item from the Accounting Office to the Office of the Municipal Planning and Development Office to augment the undermanned office.


WHEREAS, MC No. 40, S. 1998, under Rule III, Section 4 of the Omnibus Rules on Appointments and Other Personnel Actions and Sec. 26 (3) of the Civil Service Law states that transfer is the movement of employee from one position to another which is of equivalent rank, level or salary without break in the service involving the issuance of an appointment. The transfer may be from one department or agency to another or from one organizational unit to another in the same department or agency: Provided, however, that any movement from the non-career service to the career service shall not be considered a transfer.


WHEREFORE, in consideration of the request of the Municipal Mayor.


BE IT ORDAINED BY THE SANGGUNIANG BAYAN THAT:


















Section 2 - All funds covering salaries and other remunerations due the above-stated positions shall likewise be transferred.


Section 3 - Effectivity. This ordinance shall take effect upon approval.






