ORDINANCE NO. 244, S. 2014

AN ORDINANCE REALIGNING THE TEN THOUSAND PESOS (Php. 10,000.00) FROM REPAIR OF OFFICE EQUIPMENT (Account code 821) OF THE MUNICIPAL SOCIAL WELFARE AND DEVELOPMENT OFFICE OF CY 2014 MUNICIPAL ANNUAL BUDGET - TO PURCHASE OF ONE (1) SET PRINTER WITH CONTINUOUS INK FLOW OF THE SAME OFFICE.

EXPLANATORY NOTE

WHEREAS, Taken up and approved during the July 14 regular session is a letter of the Municipal Mayor endorsing the request of the DSWD office for the realignment of Ten Thousand Pesos (Php. 10,000.00) from repair of office equipment (Account Code 821) of the DSWD office of the CY 2014 Municipal Annual Budget - To purchase of one (1) set printer with continuous ink flow of the same office.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN in session assembled that:

SECTION 1. REALIGNMENT OF APPROPRIATION - The Ten Thousand Pesos (P10,000.00) appropriation for Repair of Office Equipment in the MSWD Office of the 2014 Municipal Annual Budget is hereby realigned to purchase of one unit computer printer with continuous ink flow for use of the same office.

SECTION 3. REPEALING CLAUSE - This ordinance repeals Resolution No. 635, S. 2014 dated July 14, 2014 and the pertinent portion of the current MOOE budget of the MSWD Office and such other documents affected hereby.

SECTION 2. EFFECIIVITY - This ordinance takes effect upon approval.
