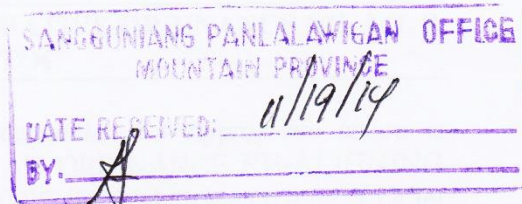

ORDINANCE NO 247, S. 2014

AN ORDINANCE RE-ALIGNING THE FIVE THOUSAND PESOS (P5,000.00) FROM COMMUNICATION EXPENSE FUND OF TWO (2) PERSONNEL OF THE ENGINEERING OFFICE (Resolution No. 623,S. 2014) - TO PAYMENT OF LOT RENTAL OF THE BONTOC WATERWORKS RESERVOIR AT BALABAG, TALUBIN.

WHEREAS, Presented for consideration and approval by this Body is a letter request of the Hon. Mayor for enactment of an appropriation ordinance re-aligning the amount of P5,000.00 under Resolution No. 623, S. 2014 for Communication Expense of two (2) personnel from the Engineering Office - to payment of lot rental of the Bontoc Waterworks Reservoir at Balabag, Talubin.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN in session assembled that:

SECTION 1. REALIGNMENT OF APPROPRIATION - The amount of FIVE THOUSAND PESOS (P5,000.00) appropriation for communication expense of two personnel from the engineering office under Resolution No. 623, S. 2014 is hereby re-aligned - to payment of Lot Rental of the Bontoc Waterworks Reservoir at Balabag, Talubin.

SECTION 2, REPEALING CLAUSE - This Ordinance repeals the affected portions of Resolution No. 623, S. 2014 dated June 23, 2014.

SECTION 3. EFFECTIVITY - This ordinance takes effect upon executive approval.
