AN ORDINANCE PROVIDING INCENTIVES TO OUTSTANDING MUNICIPAL ATHLETES WHO EXCEL IN THEIR EVENT/S DURING THE CONDUCT OF THE PROVINCIAL MEET AND PROVIDING FUNDS FOR SUCH PURPOSES.

PREFATORY

Whereas, in the Provincial Level, incentives are awarded by the Provincial Government for athletes who excel in their event/s in the conduct of Regional and National Level Sport Competitions;

Whereas, and as of the moment, there is no counterpart ordinance from this Municipality which provides for incentives for athletes who represent the latter in the Provincial Meet;


Whereas, to encourage these homegrown athletes to train hard and to excel more in their chosen event/s, this August Body and this Administration, deems it fitting that cash incentive be provided to these athletes who are successful in their respective event/s during the conduct of the Provincial Meet;

WHEREFORE, this August Body now decrees the following:

Section 1. Short Title. This Ordinance shall be known as the "Municipal Athletes' Incentives Ordinance of 2015."

Section 2. Scope. The incentives provided for in this Ordinance shall apply to athletes who are able to garner 1st or 2nd Place in their respective event/s during the conduct of the Provincial Meet while representing the Municipality of Bontoc.

Section 3. Incentives. The Municipal Government shall provide the following cash incentives for successful athletes:

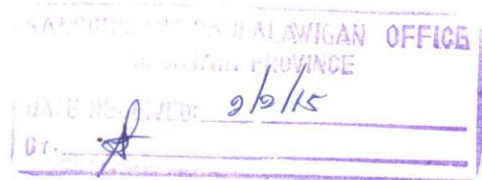


3a. Individual Sports/Events.

CHAMPION: PHP1,000.00
2ND PLACE: PHP500.00

3b. Team Events.

CHAMPION: PHP3,000.00
2ND PLACE: PHP1,000.00



3c. Special Definitions. – Without any intent to change the accepted and common definitions of "INDIVIDUAL EVENTS" and "TEAM EVENTS" but only for purposes of the application of this incentive scheme, the following are hereto clarified:

1. **"Individual Sports/Events"** – shall include events participated in by up to three (3) individuals.
2. **"Team Sports/Events"** – shall include events participated in by four (4) or more athletes.

Section 4. Funding. The Local Chief Executive shall ensure that an amount of not less than Three Hundred Thousand Pesos (PHP300,000.00) be earmarked from the General Budget and set aside to fund the obligations created by this Ordinance.

Section 5. Separability. Should any provision of this Ordinance be declared void, the remaining provisions not so voided shall continue to be in force and effect.

Section 6. Repealing Clause. All previous ordinances and municipal issuances contrary to the provisions of this ordinance are hereto repealed.

Section 7. Effectivity. This Ordinance shall take effect after ten (10) days from its publication which will be undertaken upon approval on review by the Sangguniang Panlalawigan.
