AN ORDINANCE EXTENDING THE PERIOD FOR PAYMENT OF BUSINESS TAXES, FEES AND CHARGES AND RENEWAL OF BUSINESS PERMITS AND LICENSES FROM JANUARY 20, 2015 TO JANUARY 27 2015 WITHOUT SURCHARGES AND PENALTIES.

WHEREAS, With the volume of the tax payers still lining up at the treasurers office to pay business taxes and renewal of business permits and licenses, fees and charges the approach of the deadline on January 20, 2015 there is a need to extend the deadline for payment of business tax

WHEREAS, Payment of business tax started only on January 5, 2015 thus taxpayers have only twelve (12) working days to pay up to January 20, 2015 to pay their business tax without surcharges and penalty;

WHEREAS, Section 167 of the Local Government code of 1991 provides that:

"Section 167. Time of Payment – unless otherwise provided in this code, all local taxes, fees and charges shall be paid within the first twenty (20) days of January or of each subsequent quarter, as the case maybe. The sangguniang concerned may for a Justifiable reason or course extend the time for payment of each taxes, fees or charges without surcharges or penalties, but only for a period not exceeding six (6) months"

NOW, THEREFORE, On motion of Councilor Jerome B. Tudlong Jr. and with the unanimous accord of the members of Sangguniang Bayan in session assembled, to enact the following ordinance:
