**ORDINANCE NO. 256, S. 2015**

**AN ORDINANCE REALIGNING/REAPPROPRIATING THE AMOUNT OF ONE MILLION FIVE HUNDRED THOUSAND PESOS (P1,500,000.00) FROM ITEM NO. 9000 (PURCHASE OF LANDFILL) OF THE CY 2015 MUNICIPAL AIP 2015- TO OTHER MUNICIPAL PROGRAMS OF THIS MUNICIPALITY.**

EXPLANATORY NOTE:

With the purchase of lot at sitio AM-ANCHU for the General Waste Processing Facility of the municipality, there is an urgent need to construct an access road to fastract utilization of aforesaid lot.

BE IT ORDAINED BY THESANGGUNIANG BAYAN in session assembled, that:

SECTION 1. FUND REALIGNMENT/REAPPROPRIATIONS – The amount of P1,500,000.00 from item No. 9000 of CY Municipal AIP are hereby realigned/reappropriated to wit:

1. Construction of Access Road at Am-anchu to The LGU property (General Waste Processing Facility)	P1,300,000.00
2. Purcahse of Additional lot adjacent to the General Waste Processing Facility of the municipal Government for use in the construction of the access road to the LGU property.(General Waste Processing Facility)	P 200,000.00
<b>TOTAL</b>	<b>P1,500,000.00</b>

SECTION 2-REPEALING CLAUSE – the pertinent portions of the CY 2015 municipal AIP and other documents are hereby amended accordingly.

SECTION 3. SEPARABILITY CLAUSE – Parts of this ordinance which maybe declared invalid shall not affect The other parts so invalidated.

SECTION 4. – EFFECTIVITY – This ordinance shall take effect upon approval by the chief executive.
