ORDINANCE NO. 257, S. 2015

AN ORDINANCE APPROPRIATING THE AMOUNT OF ONE HUNDRED TEN THOUSAND THREE HUNDRED SEVENTY FOUR PESOS AND THIRTY CENTAVOS (P110,374.30) FROM THE 2014 GENERAL FUND BUDGET OF THIS MUNICIPALITY FOR THE CONSTRUCTION OF WATER RESERVOIR TANK AT TOCUCAN.
