AN ORDINANCE AMENDING ITEM NO. 3, SECTION 1 OF ORDINANCE NO. 234, S. 2014, ORGANIC COMPOSTING PLANT TO BIO-ORGANIC FERTILIZER PRODUCTION.

EXPLANATORY NOTE:

WHEREAS, The municipality of Bontoc and the Department of Agriculture-Regional Field Unit, Cordillera Administrative Region made and entered into a Memorandum of Agreement (MOA).

WHEREAS, Pursuant to DBM-DILG-DSWD-NAPC Joint Memorandum Circular (JMC) No. 2, S. 2012 dated March 8, 2012, as a strategy to pursue the MDG of Reducing Poverty Bottom-Up-Budgeting (BUB) shall be piloted in 609 LGUs including the municipality of Bontoc, Mountain Province;

WHEREAS, The title of the project under the Memorandum of Agreement made and entered by the Municipal Government of Bontoc and the Department of Agriculture was *Bio-Organic Fertilizer Production*;

WHEREFORE, On motion duly seconded

BE IT ENACTED, By the Sangguniang Bayan, in session assembled, that:

Section 1. Item No. 3, section 1 of Ordinance No. 234, S. 2014 shall be amended to read as *Bio-organic Fertilizer Production*.

Section 2. That this ordinance shall form part of Ordinance No. 234, S. 2014.

Section 3. Effectivity. This ordinance takes effect upon executive approval.
