**NOW THEREFORE**, on motion of Hon. Alsannyster Patingan duly seconded by Hon. Alexander Fana-ang.




**SECTION 1** – The total amount of P1,118,275.24 from balances of 2014 municipal projects is hereby renamed/realigned to the following:


