MUNICIPAL HEALTH CARE ORDINANCE OF 2015


WHEREAS, Pursuant to Sec. 5 of P.D. No. 1597, S. 1978 (Further Rationalizing the System of Compensation and Position Classification in the National Government), which continuous to be applicable in accordance with RA. No. 6758, s. 1989 (Prescribing a Revised Compensation and Position Classification System in the Government), all government employees may be granted allowances, honoraria and other fringe benefits;

WHEREAS, Keeping a healthy workforce is among the primary concerns of the government considering that the physical well-being of its employees has a significant impact on the efficiency and effectiveness of public service delivery;

WHEREFORE, Foregoing considered be it enacted, by the Sangguniang Bayan in session assembled that;

Section 1. **Establishment of the Annual Medical Check-up Program.** – An annual medical check-up for municipal government officials and employees is hereby authorized to be established starting this year.

Section 2. **Coverage** – The medical check-up program shall be granted to all permanent and Elected personnel of the Local government unit of Bontoc .



Section 3. **Benefit Package** – Benefits for employees shall include the following: Physical examination, Chest X-ray, Complete Blood Count (CBC), Urinalysis, Stool Examination, ECG, Blood Chemistry which shall include the following Fasting Blood Sugar (FBS), Blood Urea Nitrogen Levels (BUN), Creatinine (CREA), Total Cholesterol (TC), Triglyceride (TG), and Blood Uric Acid (BUA). Benefits may be increased upon availability of funds.

Section 4. **Date of Medical Check-up** – The annual medical check-up shall be availed by the employee on the day of their birthday and if the birthday falls on a weekend or Holiday it will be on the next regular working day.

Section 5. **Funding** – The Municipal Government shall appropriate P500, 000.00 to cover the cost of the medical check-up of officials and employees of the Local Government Unit of Bontoc in its Annual Budget.

Funds intended for the program shall be used only for the payment of the cost of check-up actually rendered.

Section 6. **Implementing Rules and Regulations** – The Office of the Mayor formulate and issue the implementing rules and regulations for this program.

Section 7. **Repealing Clause** – All laws, orders, regulations, or parts thereof, inconsistent with the provisions of this Order, are hereby repealed or modified accordingly.

Section 8. **Repealing Clause** – All laws, orders, regulations, or parts thereof, inconsistent with the provisions of this Order, are hereby repealed or modified accordingly.

Section 9. **Effectivity** – This ordinance shall take effect immediately upon executive approval.
