
AN ORDINANCE REPEALING ORDINANCE No. 257, S. 2015, TITLED: "AN ORDINANCE APPROPRIATING THE AMOUNT OF ONE HUNDRED TEN THOUSAND THREE HUNDRED SEVENTY FOUR PESOS AND THIRTY CENTAVOS (P110,374.30) FROM THE 2014 GENERAL FUND BUDGET OF THIS MUNICIPALITY FOR THE CONSTRUCTION OF WATER RESERVOIR TANK AT TOCUCAN" FOR LAPSE OF SOURCE OF FUNDING.


BE IT ENACTED.


SECTION 1. Ordinance No. 257, S.2015 titled "AN ORDINANCE APPROPRIATING THE AMOUNT OF ONE HUNDRED TEN THOUSAND THREE HUNDRED SEVENTY FOUR PESOS AND THIRTY CENTAVOS (P110,374.30) FROM THE 2014 GENERAL FUND BUDGET OF THIS MUNICIPALITY FOR THE CONSTRUCTION OF WATER RESERVOIR TANK AT TOCUCAN" is hereby repealed and declared inoperative for the reason that the funding source thereof has lapsed rendering the contemplated funding thereof non existent, as per the Books of the LGU.


