ORDINANCE NO. 268, S. 2015

**AN ORDINANCE ABOLISHING THE POSITION OF PRIVATE SECRETARY, SG-11 IN THE PLANTILLA OF THE VICE MAYOR'S OFFICE, This LGU, AND CREATING – IN ITS PLACE THE POSITIONS OF ADMINISTRATIVE AIDE II, SG-2 AND ADMINISTRATIVE AIDE I, SG-1 AND AUTHORIZING THE FUNDS THEREFOR.**

EXPLANATORY NOTE

WHEREAS, In the interest of public welfare and of a streamlined governance for a more effective public service delivery – there is a need to reassemble LGU resources in order to meet service realities on the ground;


WHEREAS, The workload and usefulness of the Private Secretary item can be well discharged by the Executive Assistant Item in the Vice Mayor's Office and any other personnel need therein can be filled by job order manpower;

WHEREAS, The fund requirements for the 2 newly created positions shall be sourced from the fund appropriation for the abolished position, and with the minimal amount of P 38,157.32 deficit be augmented from unprogrammed funds;

NOW, THEREFORE,

BE IT ENACTED, by this Sangguniang Bayan, In session assembled, that:

SECTION 1 – ABOLITION OF POSITION AND CREATIONS OF OTHER POSITIONS IN ITS PLACE (SCRAP & BUILD SCHEME) – the position of PRIVATE SECRETARY, SG -11 in the plantilla of the Vice Mayor's Office is hereby abolished, and in its place, the positions of ADMINISTRATIVE AIDE II, SG-2 and ADMINISTRATIVE AIDE I, SG-1 are hereby created, on the scrap and build scheme;













SECTION 2 – FUNDING AUTHORIZATION – The annual fund appropriations for the abolished Private Secretary Position are hereby authorized for the fund requirements of the newly created Administrative Aide II, SG-2 and Administrative Aide I, SG-1 positions, and the amount of P 38,157.32 deficiency to fully cover their full requirements is hereby further authorized to be sourced from available municipal funds;

SECTION 3 – SEPARABILITY CLAUSE – The parts of this ordinance are separable. Any part hereof which maybe invalidated shall not affect the other parts not so invalidated;

SECTION 4 – REPEALING CLAUSE – All ordinances, plantilla, budgets and other such documents contrary hereto are hereby repealed or amended accordingly;

SECTION 5 – EFFECTIVITY – This ordinance takes effect upon executive approval.
