ORDINANCE NO. 269, S. 2015

AN ORDINANCE TO CONVERT THE POSITION OF LOCAL LEGISLATIVE STAFF EMPLOYEE II, SG-4, UNDER THE SB OFFICE - TO TAX MAPPING AIDE I, SG-4 AND TRANSFERRING IT TO THE OFFICE OF THE MUNICIPAL ASSESSOR.

EXPLANATORY NOTE

WHEREAS, Pursuant to Section 76 of RA 7160 of the Local Government Code of 1991, provides that organization structure and staffing patterns – "every local government unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirements and financial capability, subject to the minimum standards and guidelines prescribed by the civil service.

WHEREAS, the position of Local Legislative Staff Employee II, SG-4 in the Office of the Sangguniang Bayan was created under Res. NO. 193, S. 2005;

WHEREAS, The Body deliberated on this matter and is of the consensus that the conversion does not entail any increase or decrease in the salary because the new position has the same salary grade from the position being requested to be converted;

NOW, THEREFORE,

BE IT ENACTED, by this Sangguniang Bayan, In session assembled, that:

SECTION 1 – CONVERSION AND TRANSFER OF POSITION - The position of Local Legislative Staff Employee II, SG-4 in the plantilla of the Sangguniang Bayan is hereby converted to Tax Mapping Aide I, SG-4 and to be transferred to the office of the Municipal Assessor.

SECTION 2 – FUNDING AUTHORIZATION – The annual fund appropriations for the converted Local Legislative Staff Employee II, SG-4 is hereby authorized to fund the Position of Tax Mapping Aide I, SG-4;


ORDINANCE NO. 269, S. 2015 – CONVERSION OF POSITION
