ORDINANCE NO. 275, S. 2016

AN ORDINANCE CONVERTING THE POSITION OF CIVIL DEFENSE ASSISTANT FOR RESEARCH AND PLANNING SG-8 (Under the Municipal Disaster Risk and Reduction Management Office) TO THE POSITION OF NURSING ATTENDANT II, SG-6.

WHEREAS, Section 447 (a)(1)(viii) of R.A. 7160 empowers the Sangguniang Bayan, as the legislative body of the municipality, to enact ordinances and adopts resolutions necessary for an efficient and effective municipal government, and in this connection shall ***determine the positions and the salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from municipal fund . . .***


WHEREAS, the Honorable Mayor, in his letter dated January 13, 2016 requests the conversion of the position of Civil Defense Assistant for Research and Planning to Nursing Attendant II, emphasizing that the conversion does not entail additional funds but lessens the personal services requirements;

WHEREAS, finding the request to be in order, and on motion duly seconded,

BE IT ENACTED, By this Sangguniang Bayan in regular session assembled, that:

SECTION 1. CONVERSION OF POSITION. – The position of CIVIL DEFENSE ASSISTANT FOR RESEARCH AND PLANNING SG-8 (Under the Municipal Disaster Risk and Reduction Management Office) is hereby converted to the position of NURSING ATTENDANT II, SG-6.

SECTION 2. SEPARABILITY CLAUSE – Any part of this ordinance which maybe declared invalid by proper authority shall not invalidate the other parts hereof which are not so declared invalid, and these shall remain in full force and effect.

SECTION 3. REPEALING CLAUSE – All Bontoc Municipal Ordinances, Resolutions, records which are inconsistent hereto, and the pertinent parts of the Bontoc Municipal plantilla affected by this ordinance are hereby repealed and/or modified accordingly.

SECTION 4. EFFECTIVITY – This ordinance shall take effect fifteen days upon posting in the Municipal Hall Bulletin board.
