ORDINANCE NO. 277, S. 2016

AN ORDINANCE CREATING VARIOUS POSITIONS IN THE MUNICIPAL PLANTILLA OF THIS MUNICIPALITY AND PROVIDING THE CORRESPONDING SALARY GRADES THEREOF.

EXPLANATORY NOTE

WHEREAS Sec. 76 of the Local Government Code states that every local government unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirements and financial capability, subject to the minimum standards and guidelines prescribed by the Civil Service Commission.

WHEREAS, The Honorable Mayor in his letter dated January 29, 2016 requests for the creation of vital positions that will enhance the staffing structures that is fitted to a First and Second Class municipality and likewise to close the gap of next in rank positions in the municipality;

WHEREAS, finding the requests in order, and on motion duly seconded,

BE IT ORDAINED BY THIS SANGGUNIANG BAYAN in session assembled that:

SECTION 1 – **CREATION OF PLANTILLA POSITIONS AND SALARY GRADES** – The following positions are hereby created in the plantilla of the municipal Government of Bontoc;
