ORDINANCE NO. 278, S. 2016

AN ORDINANCE ABOLISHING THE POSITION OF MARKET INSPECTOR 1, SG-6 AND CREATING THE POSITION OF NURSING ATTENDANT II, SG-6 IN LIEU THEREOF AND REPEALING ORDINANCE NO. 276, S. 2016 FOR THESE PURPOSES.

WHEREAS, Sec. 447 (a)(1)(viii) of R.A. 7160 empowers the Sangguniang Bayan to enact ordinance and adopt resolutions necessary for an efficient and effective municipal government, and in this connection, "*shall determine the positions and salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from municipal funds, xx. . .*";

WHEREAS, in line with this power, this Sangguniang Bayan on 21 March 2016 enacted Municipal Ordinance No. 276, S. 2016 bearing TITLE" AN ORDINANCE ABOLISHING THE POSITION OF MARKET INSPECTOR I, SG-6 AND CREATING THE POSITION OF TICKET CHECKER, SG-3 IN LIEU THEREOF;

WHEREAS, even with its passage, Ordinance No. 276, S. 2016, was not transmitted for review to the Sangguniang Panlalawigan considering the onset of the 2016 Local and National Elections and the anticipated possible delays of the review process and the implementation thereof due to the Election Ban on Appointments;

WHEREAS, and even with its passage, it was never implemented by the Local Chief Executive;

WHEREAS, and considering the present circumstances, it has become apparent that the Municipality is in need more of a Nursing Attendant than a ticket Checker;










WHEREFORE AND FOREGOING CONSIDERED, this Sangguniang Bayan invoking the same powers vested to it by Sec. 447 (a) (1) (viii) of the Local Government Code, in a session duly assembled and on motion duly seconded hereto DECREES the following;


- Section 1: ABOLITION – The existing position of MARKET INSPECTOR I, SG-6, is hereto abolished and deleted from the plantilla of the Municipality.
- Section 2: CREATION – The Position of NURSING ATTENDANT II, SG-6, is hereto created and included into the plantilla of the Municipality.
- Section 3: SPECIFIC REPEAL – To avoid any confusion, Ordinance NO. 276, S. 2016 bearing TITLE: AN ORDINANCE ABOLISHING THE POSITIOON OF MARKET INSPECTOR I, SG-6 AND CREATING THE POSITION OF TICKET CHECKER, SG-3 IN LIEU THEREOF, enacted on 21 March 2016, is hereto REPEALED and rendered no force and effect.
- Section 4: SEPARABILITY – Any part of this Ordinance which may be declared invalid by proper authority shall not invalidate the other parts hereof which are not so declared invalid.
- Section 5: GENERAL REPEAL – All other ordinances, Resolutions, Records, Issuances which are inconsistent hereto, and the pertinent parts of the Bontoc Municipal Plantilla affected by this Ordinance are hereto repealed and/or modified accordingly.
- Section 6: EFFECTIVITY – This ordinance shall take effect after a posting period of fifteen (15) days in the Municipal Hall Bulletin Board.
