ORDINANCE NO. 279, S. 2016

AN ORDINANCE REALIGNING THE AMOUNT OF FOUR HUNDRED THIRTY THREE THOUSAND AND SEVENTY ONE PESOS (P 433,071.00) SALARY SAVINGS FOR THE IPMR (APRIL-DECEMBER 2016), FOR AUGMENTATION FUND FOR THE SALARY OF FIVE NEW POSITIONS; LEGISLATIVE PROGRAMS; EXECUTIVE PROGRAMS AND INCREASE OF MUNICIPAL OFFICE RENTAL

WHEREAS, Sec. 447 (a)(1)(viii) of R.A. 7160 empowers the Sangguniang Bayan to enact ordinance and adopt resolutions necessary for an efficient and effective municipal government;

NOW THEREFORE,

BE IT ORDAINED, by the Sangguniang Bayan, in session assembled, that;

SECTION 1 – Fund Realignment – The amount of FOUR HUNDRED THIRTY THREE THOUSAND AND SEVENTY ONE PESOS (P 433,071.00) savings from the IPMR Salary (April-December 2016) is hereby realigned for augmentation fund for the salary of five new positions – P 193,131.12; Legislative Programs – P 119,969.94; Executive Programs – P 42,969.94 and Increase Municipal Office Rental – P 77,000.00;

SECTION 2 – SEPARABILITY CLAUSE – Any part of this ordinance which maybe invalidated shall not affect the other parts not invalidated, and these shall remain in effect.

SECTION 3 – REPEALING CLAUSE – The pertinent portion of the 2016 Annual Budget of the SB Office affected hereby are hereby repealed or amended accordingly;

SECTION 4 - EFFECTIVITY – This ordinance takes effect after review approval.


