ORDINANCE NO. 280, S. 2016

AN ORDINANCE REALIGNING THE AMOUNT OF FIFTY ONE THOUSAND PESOS (P 51,000.00) BUDGETED FOR OFFICE SUPPLIES, TRAININGS/SEMINARS OF THE MUNICIPAL TRIAL COURT OF CY 2016 ANNUAL BUDGET TO PURCHASE OF DESKTOP COMPUTERS AND CPU OF THE SAME OFFICE

WHEREAS, Sec. 447 (a)(1)(viii) of R.A. 7160 empowers the Sangguniang Bayan to enact ordinance and adopt resolutions necessary for an efficient and effective municipal government;

NOW THEREFORE,

BE IT ORDAINED, by the Sangguniang Bayan, in session assembled, that;

SECTION 1 – Fund Source – The amount of Fifty One Thousand Pesos (P 51,000.00) from office supplies, trainings/seminars of the Municipal Trial Court of the 2016 Annual Budget.

SECTION 2 – FUND APPROPRIATION – Purchase of desktop computers and CPU

SECTION 3 – SEPARABILITY CLAUSE – Any part of this ordinance which maybe invalidated shall not affect the other parts not invalidated, and these shall remain in effect.

SECTION 4 – REPEALING CLAUSE – The pertinent portion of the 2016 Annual Budget of the Office of the Municipal Trial Court is hereby repealed or amended accordingly;


SECTION 5 - EFFECTIVITY – This ordinance takes effect after review approval.
