ORDINANCE NO. 281, S. 2017

AN ORDINANCE AMENDING THE NOMENCLATURE OF THE POSITION OF MUNICIPAL GOVERNMENT DEPARTMENT HEAD I (Legal Officer V), SALARY GRADE 24, IN THE PLANTILLA OF THE MUNICIPAL GOVERNMENT OF BONTOC, MOUNTAIN PROVINCE – TO MUNICIPAL LEGAL OFFICER I, SALARY GRADE 24.

EXPLANATORY NOTES

WHEREAS, There is a new, vacant position of Municipal Government Department Head I (Legal Officer V), Salary Grade 24 under item "NEW" of the plantilla of the Municipal Government of Bontoc, Mountain Province;

WHEREAS, The said new, vacant position was created under and by virtue of Municipal Ordinance No. 270, S. 2015, and was further approved – in – review by the Sangguniang Panlalawigan of Mountain Province under its Resolution No. 2015-452 dated December 8, 2015;

WHEREAS, The Bontoc Municipal Government is having a difficulty in filling up the said vacant position due to its minimum qualification standard of 5 years experience which new lawyers can not meet and seasoned lawyers are not keen to take;

WHEREAS, There is a position of Municipal Legal Officer I, Salary Grade 24, which has substantially similar functions as the aforesaid vacant position but with only 3 years of minimum experience required – which should make it easier for applicants to comply, and for the municipality to finally avail of the services of a full-fledge legal officer.

WHEREFORE,

BE IT ENACTED BY THE SANGGUNIANG BAYAN, in session assembled on January 23, 2017 that:

SECTION I. **AMENDMENT OF SECTION I, ORDINANCE NO. 270, S. 2015 Creating 7 Plantilla Positions and Salary Grades** - Item No. 1 of Ordinance No. 270, S. 2015 is hereby amended to finally read as follows:

"1. Municipal Legal Officer I ----- 24"

SECTION 2 – Amendment of Municipal Plantilla – The position of Municipal Government Department Head I (Legal Officer V), salary grade 24, under item “new” in the PLANTILLA of the Municipal Government of Bontoc is hereby amended to: “MUNICIPAL LEGAL OFFICER I, Salary Grade 24”.

SECTION 3 – REPEALING CLAUSE – All Ordinances, resolutions, plantilla of positions and other municipal documents which are inconsistent with this ordinance are hereby repealed, amended or modified accordingly;






