ORDINANCE NO. 291, S. 2017

AN ORDINANCE REALIGNING THE AMOUNT OF THIRTY FIVE THOUSAND PESOS (P 35,000.00) FROM THE TRAININGS AND SEMINARS OF THE SANGGUNIANG BAYAN MEMBERS AND THREE THOUSAND FIVE HUNDRED PESOS (P 3,500) FROM THE TRAININGS AND SEMINARS OF THE VICE MAYOR FOR A TOTAL OF P 38,500.00 FOR THE FABRICATION OF NAMEPLATES OF THE SB MEMBERS AND THE VICE MAYOR.

WHEREAS, Sec. 447 (a)(1)(viii) of R.A. 7160 empowers the Sangguniang Bayan to enact ordinance and adopt resolutions necessary for an efficient and effective municipal government;

NOW THEREFORE,

BE IT ORDAINED, by the Sangguniang Bayan, in session assembled, that;

SECTION 1 – Fund Source – The amount of P 35,000.00 trainings and Seminars of the SB Members and P 3,500.00 from trainings and seminars of the Vice Mayor's Office of the 2017 Annual Budget.

SECTION 2 – FUND APPROPRIATION – Fabrication of Nameplates of Vice Mayor and SB Members

SECTION 3 – SEPARABILITY CLAUSE – Any part of this ordinance which maybe invalidated shall not affect the other parts not invalidated, and these shall remain in effect.

SECTION 4 – REPEALING CLAUSE – The pertinent portion of the 2017 Annual Budget of the Sangguniang Bayan and The Vice Mayor is hereby repealed or amended accordingly;

SECTION 5 - EFFECTIVITY – This ordinance takes effect after review approval.
