ORDINANCE NO. 295, S. 2017

AN ORDINANCE REALIGNING THE AMOUNT OF NINETEEN THOUSAND ONE HUNDRED TWENTY FIVE PESOS (P 19,125.00) BUDGETED FOR TRAININGS/SEMINARS OF THE MUNICIPAL TRIAL COURT OF CY 2017 ANNUAL BUDGET TO PURCHASE OF TWO (2) COMPUTER PRINTERS OF THE SAME OFFICE

WHEREAS, Sec. 447 (a)(1)(viii) of R.A. 7160 empowers the Sangguniang Bayan to enact ordinance and adopt resolutions necessary for an efficient and effective municipal government;

NOW THEREFORE,

BE IT ORDAINED, by the Sangguniang Bayan, in session assembled, that;

SECTION 1 – Fund Source – The amount of Nineteen Thousand One Hundred Twenty Five Pesos (P 19,125.00) from trainings/seminars of the Municipal Trial Court of the 2017 Annual Budget.

SECTION 2 – FUND APPROPRIATION – Purchase of two (2) EPSON LQ-300 computer printers.

SECTION 3 – SEPARABILITY CLAUSE – Any part of this ordinance which maybe invalidated shall not affect the other parts not invalidated, and these shall remain in effect.

SECTION 4 – REPEALING CLAUSE – The pertinent portion of the 2017 Annual Budget of the Office of the Municipal Trial Court is hereby repealed or amended accordingly;
