AN ORDINANCE CREATING THE POSITION OF LIBRARIAN II, (SG-15), UNDER THE OFFICE OF THE SANGGUNIANG BAYAN, BONTOC, MOUNTAIN PROVINCE

EXPLANATORY NOTE

WHEREAS, RA 7743 provides for the establishment of Congressional, City and Municipal Libraries and Barangay Reading Centers throughout the Philippines, appropriating the necessary funds therefore and for other purposes;

WHEREAS, Section 3 of its Implementing Rules and Regulations provides that the Librarian for 2nd class municipalities shall have the position of Librarian II (SG-14);

WHEREAS, Under Local Budget Circular No. 2009-92 dated September 3, 2009, the positions provided by RA 7743 relative to Librarian positions had been elevated one grade higher, verily, the Librarian II position is understood as having a re-allocated grade of SG 15;

WHEREFORE, FOREGOING CONSIDERED,

BE IT ORDAINED BY THIS SANGGUNIANG BAYAN in session assembled that:

SECTION 1. CREATION. – The position of Librarian II, SG-15 is hereby created in the plantilla of the Municipal Government of Bontoc;

SECTION 2. EFFECTIVITY – This ordinance takes effect upon executive approval.
