**ORDINANCE NO. 312, S.2019**

**AN ORDINANCE OPENING ONE HUNDRED (100) ADDITIONAL TRICYCLE FRANCHISES FOR THE MUNICIPALITY OF BONTOC, MOUNTAIN PROVINCE.**

**WHEREAS**, and as a necessary consequence of the growth of the Municipality's population, there is a need to increase the existing number of tricycle franchises, to sufficiently serve the basic transportation needs of this sector of society;

**WHEREAS**, and with the end in view of attaining sufficient tricycle transportation service vis-à-vis the number of the riding public to be served, this august body in this meeting duly assembled, NOW THEREFORE DECREE the following, viz:

**SECTION 1.** Opening - In addition to those already existing prior to the effectivity of this Ordinance, there is hereto opened/created One Hundred (100) new tricycle franchises for this municipality.

**SECTION 2.** Authority of the Municipal Tricycle Franchising Regulatory Board (MTRFB) - The MTRFB is hereto given the task of overseeing the disposition of these newly opened franchises taking into consideration the provisions of Ordinance No. 300, S.2018, which provides the guidelines and requirements for the issuances of franchises in this jurisdiction.

**SECTION 3.** Separability - Should any provision of this Ordinance be declared null and void, such declaration of nullity shall not affect the other provisions hereof.

**SECTION 4.** Effectivity - This ordinance shall take effect immediately upon approval by the Chief Executive.
