AN ORDINANCE GRANTING OTHER BONUSES AND ALLOWANCES (HAZARD PAY) TO REGULAR EMPLOYEES OF THE MUNICIPAL SOCIAL WELFARE AND DEVELOPMENT OFFICE, BONTOC, MOUNTAIN PROVINCE.

EXPLANATORY NOTE

WHEREAS, Republic Act No. 9433 and its implementing Rules and Regulation provides for the Magna Carta for Public Social Workers;

WHEREAS, DBM national Budget Circular No. 451,S.1996 provides that compensation premium or allowance may be provided to officials and employees, who because of the nature of their work, are exposed to hazard maybe covered with the prescribed hazard duty;

WHEREAS, Regular employees of the Municipal Social Welfare and Development Office are exposed to hazardous work area as they attend to emergency operations where their lives are place at risk;

WHEREAS, Our country experience natural calamity such as typhoons and southwest monsoon that cause flooding and render many roads impassable in many areas of our municipality. In situation like this the Municipal Social Welfare and Development Office (MSWD) place a vital role in addressing the needs of the affected residents. Most of the times, the MSWD stake their lives to give humanitarian assistance to those affected by the calamity.

BE IT ENACTED BY THE SANNGUNIANG BAYAN in session that:




SECTION 2. PROVISION FOR HAZARD PAY : a maximum amount of One thousand pesos (P1,000.00) per month be granted to all regular employees of MSWD office regardless of the period of exposure.

SECTION 3. FUNDING: The Local chief executive shall appropriate funds to pay for the personnel benefits of the MSWD Office regular employees granted by this ordinance and that the same shall be included in the annual budget of the municipality annually.

SECTION 4: EFFECTIVITY: This ordinance shall take effect upon approval of the mayor and review of the Sangguniang Panlalawigan.
